## What is this product?

### Type

This is an open-ended investment company with variable capital segregated liability between sub-funds, incorporated with limited liability in Ireland.

### Objectives

**Investment objective** The Fund seeks to achieve income and growth through investment primarily in investment grade debt securities, of issuers mostly based in Europe (both EU and non EU member states), the United States, Canada, Australia, New Zealand and Japan.

**Investment policies** Payden & Rygel Global Limited (the "Investment Manager") will actively select, purchase and sell securities with the aim of meeting the investment objectives of the Fund. The Fund will invest primarily in investment grade debt securities issued by governments, government agencies, supranationals (e.g. the World Bank) and corporations. The Fund may also invest in below investment grade securities.

The Fund may also invest in money-market securities and mortgage-backed and asset-backed securities.

The Fund may use derivatives with the aim of managing interest rate and currency risk more efficiently.

The Fund may also use derivatives for both hedging purposes and for taking investment positions. These may include short positions where the Fund seeks to benefit from the sale of an asset that it does not physically own.

**SFDR Classification** The Fund has been classified as a financial product subject to Article 8 of the Sustainable Finance Disclosure Regulation (EU) 2019/2088.

**Benchmark** The Fund is actively managed with reference to a Benchmark. The performance will be used against FTSE World Government Bond Index 1-3yr (USD Unhedged). The Index is used (i) as a universe from which to select or hold securities; and (ii) to measure performance of the Fund.

The investment manager has discretion over the composition of the portfolio of the Fund and may select securities not included in the Index. However, in normal market circumstances, whilst it is expected that a significant portion of the Fund's constituents will also be Index constituents, deviations from the Index may be material. Whilst the investment manager does not employ a defined strategy to align with a benchmark during periods of volatility, it will take account of market environment and perceived risks at any given time and will employ its investment discretion as described in the investment policy accordingly.

**Redemption and Dealing** Shares can normally be bought and sold on any business day, being a day on which banks are open for business in Ireland, the UK and the US.

**Distribution Policy** Your shares are accumulating, meaning that income and gains of the Fund will be reinvested to increase the value of the Fund.

**Launch date** The Fund was launched on 22/07/1999 and the share class was not launched yet.

**Fund Currency** The base currency of the Fund is USD and this share class currency is SEK. Typically, assets held by the Fund which are denominated in a currency other than the base currency may be hedged or substantially hedged to the base currency. The base currency is in turn hedged to Swedish Krona in this share class.

**Switching** Shareholders may switch some or all of their Shares in one Fund to Shares in another Fund.

**Asset Segregation** The Company is organised under Irish law as an umbrella fund with segregated liability between funds.

### Intended retail investor

This product is intended for investors who plan to stay invested for at least 2 years and are prepared to take on a low level of risk of loss to their original capital in order to get a higher potential return. It is designed to form part of a portfolio of investments.

### Term

The Fund is open-ended and has no maturity date. Subject to the liquidation, dissolution and termination rights of the Directors of the Company as set forth in the prospectus, the Fund cannot be automatically terminated. The PRIIP Manufacturer, Waystone Management Company (IE) Limited, is not entitled to terminate the product unilaterally.

### Risks

## What happens if Waystone Management Company (IE) Limited is unable to pay out?

The Management Company has no obligation to pay out since the Fund design does not contemplate any such payment being made. You are not covered by any national compensation scheme. To protect you, the assets are held with a separate company, a depository. Should the Fund default, the depository would liquidate the investments and distribute the proceeds to the investors. In the worst case, however, you could lose your entire investment.

## What are the costs?

### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario,
- 10,000 SEK is invested.
