Payden Funds' distributor may lower or waive the minimum initial investment for certain categories of investors at their discretion. ^D Effective duration is a measure of the Fund's price sensitivity to changes in interest rates. ^E The 30-day SEC yield represents the dividends and interest earned for a 30-day period, annualized, and divided by the net asset values per share at the end of the period. The SEC yield is computed under a standardized formula which assumes all portfolio securities are held to maturity. This value may differ from the actual distribution rate of the fund.

Market

- » High-yield bonds posted a strong result for the quarter as tighter spreads (i.e., the difference between the yield on bonds and comparable-maturity U.S. Treasuries) and coupon income both worked in investors' favor.
- » The ICE BofA BB-B U.S. Cash Pay High Yield Constrained Index returned +3.5% during the quarter. BB-rated bonds returned +3.4%, B-rated bonds returned +3.5%, and CCC-rated bonds returned +4.6%.
- » New issuance was \$77 billion (\$23 billion net of refinancing) in the second quarter. Year-to-date, the market has seen \$146 billion (\$40 billion net of refinancing) of new issue.
- » High-yield mutual fund and exchange-traded fund (ETF) flows were -\$0.1 billion during the quarter.

Outlook

- » Issuer-level data shows sturdy high-yield fundamentals as disciplined management teams have kept leverage in check and cash flow ratios healthy.
- » Very few issuers need immediate access to capital markets, which should give them runway to reposition for the new global economic dynamic.
- » We view all-in yields as attractive in the low-7% range, but active management will remain critical in the coming months.
