Investment Strategy

The Payden Floating Rate Fund's investment objective is to seek a high level of current income through floating-rate debt instruments, with a secondary objective of long-term capital appreciation. At least 80% of fund assets will be floating rate. The fund generally invests in the higher-quality segment of the market and looks for companies with good growth prospects, superior products, and strong management teams.

Fund Highlights

- » High-yield loan focus. Opportunistic exposure to short-term high-yield corporates.
- » Payden primarily focuses on the higher quality end of the high-yield loan market. We believe that the risk-return profile of BB and high single-B rated loans is superior to that of lower-rated loans.
- » Due to the size of the fund, we can buy the loans we want and get meaningful new issuance allocations, which is difficult for funds with assets above \$1 billion.
- » The primary risk to the fund is a downturn in the economy.

The Floating Rate Fund's performance since 01/31/2019 is 5.64%. ^C The minimum initial investment may be modified for certain financial intermediaries that submit trades on behalf of underlying investors. Payden Funds' distributor may lower or waive the minimum initial investment for certain categories of investors at their discretion. ^D Effective duration is a measure of the Fund's price sensitivity to changes in interest rates. ^E The 30-day SEC yield represents the dividends and interest earned for a 30-day period, annualized, and divided by the net asset values per share at the end of the period. The SEC yield is computed under a standardized formula which assumes all portfolio securities are held to maturity. This value may differ from the actual distribution rate of the fund. ^F Represents a 30-day SEC yield without adjusting for fee waivers or expense reimbursements. ^G Total Annual Fund Operating Expenses include all direct operating expenses of the Fund, as well as 0.01% Acquired Fund Fees and Expenses incurred indirectly by the Fund through its investment in other mutual funds. Payden & Rygel has contractually agreed to limit Total Annual Fund Operating Expenses After Fee Waiver or Expense Reimbursement to 0.60%. This agreement has a one-year term ending February 28, 2026. Please note that the 0.60% expense level does not include Acquired Fund Fees and Expenses, interest, taxes, and extraordinary expenses. ^H Ratings are measured on a scale that generally ranges from AAA (highest) to D (lowest) and are subject to change. Security ratings are assigned using the highest rating of Moody's, S&P, and Fitch.

Market

- » The Bloomberg U.S. Leveraged Loan Index returned +2.1% for the quarter. In contrast, high-yield bonds returned +3.6%, while high-grade bonds returned +1.8%.
- » Loan issuance during the quarter was \$104 billion (\$41 billion net of refinancing and repricing). Year-to-date issuance stands at \$441 billion (\$102 billion net).
- » The loan default rate was 3.8% (including distressed exchanges) over the trailing 12 months.

Outlook

- » An environment characterized by lower growth would disproportionately impact the lower-quality segment of the loan market, which has a higher leverage profile and is more sensitive to the macroeconomic environment. This makes security selection critical in the coming quarters.
- » The Federal Reserve could potentially offset growth concerns, as cuts to the federal funds rate immediately impact loan issuers in the form of reduced interest expense and increased cash flow.
- » With average loan prices now around \$97.00, we see more compelling opportunities for above-carry returns among certain issuers, although downside avoidance will be critical in the coming months, particularly as economic dynamics are changing constantly.
