What is this product?

Type

This is an open-ended investment company with variable capital segregated liability between sub-funds, incorporated with limited liability in Ireland.

Objectives

Investment objective The Fund aims to track the total returns, income and capital combined, of global developed market government bonds as reflected by the Index, the FTSE World Government Bond Index (Currency Hedged) . The Fund aims to track the total returns, income and capital combined, of global developed market government bonds as reflected by the Index

Investment policies Payden & Rygel Global Limited (the "Investment Manager") will select, purchase and sell securities with the aim of meeting the investment objectives of the Fund. The Fund will invest primarily in a representative sample of the bonds contained in the Index.

The Fund may also invest in money-market securities.

The Fund may use derivatives with the aim of managing interest rate and currency risk more efficiently.

The Fund may also use derivatives for both hedging purposes and for taking investment positions. These may include short positions where the Fund seeks to benefit from the sale of an asset that it does not physically own.

SFDR Classification The Fund has been classified as a financial product subject to Article 6 of the Sustainable Finance Disclosure Regulation (EU) 2019/2088.

Benchmark The Fund is passively managed with the objective of tracking the return of the FTSE World Government Bond Index (Currency Hedged) (previously named Citigroup World Government Bond Index) (the "Index"), gross of fees and costs.

The Index is also used (i) as a universe from which to select or hold securities; and (ii) to measure performance of the Fund. The anticipated annual normal tracking error (which means the volatility of the difference between the return of the Fund and the return of the Index), in normal market conditions, relative to the Index is 0.05%-0.15%.

Redemption and Dealing Shares can normally be bought and sold on any business day, being a day on which banks are open for business in Ireland, the UK and the US.

Distribution Policy Your shares are accumulating, meaning that income and gains of the Fund will be reinvested to increase the value of the Fund.

Launch date The Fund was launched on 26/05/2016 and the share class was launched on 26/05/2016.

Fund Currency The base currency of the Fund is USD and this share class currency is USD.

Switching Shareholders may switch some or all of their Shares in one Fund to Shares in another Fund.

Intended retail investor

This product is intended for investors who plan to stay invested for at least 2 years and are prepared to take on a low level of risk of loss to their original capital in order to get a higher potential return. It is designed to form part of a portfolio of investments.

Term

The Fund is open-ended and has no maturity date. Subject to the liquidation, dissolution and termination rights of the Directors of the Company as set forth in the prospectus, the Fund cannot be automatically terminated. The Investment Manager is not entitled to terminate the product unilaterally.

What are the risks and what could I get in return?

Risks

Performance scenarios

What happens if Payden & Rygel Global Limited is unable to pay out?

You may face a financial loss if the Fund defaults on their obligations. If the Fund is unable to pay you out what the Fund owes you, you are not covered by any guarantee or national compensation scheme. The assets of the product are held in safekeeping by the Depositary and are separate assets to those of the Fund. Therefore, in the event of the insolvency of the Fund, the products and assets will not be affected. In the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund.
